PROPOSED TAX LEVY – (RENEWAL) WYANDOT COUNTY

A Majority Affirmative Vote Is Necessary For Passage

A renewal of a tax for the benefit of Wyandot County for the purpose of the operation of community programs and services authorized by the Wyandot County Board of Developmental Disabilities (Angeline) and for the operation of developmental disabilities facilities for the same purpose, at a rate not exceeding 1.5 mills for each one dollar of valuation, which amounts to fifteen cents (\$0.15) for each one hundred dollars of valuation, for five years, commencing in 2022, first due in calendar year 2023.

PROPOSED TAX LEVY – (RENEWAL) CITY OF UPPER SANDUSKY

A Majority Affirmative Vote Is Necessary For Passage

A renewal of a tax for the benefit of the City of Upper Sandusky for the purpose of current expenses at a rate not exceeding 1.3 mills for each one dollar of valuation, which amounts to thirteen cents (\$0.13) for each one hundred dollars of valuation, for five years, commencing in 2022, first due in calendar year 2023.
